Brexit: Implications of the final Draft Agreements

The expectation on both sides of the Channel is that agreement will be reached by October or more likely, November, of this year on the terms of the UK's withdrawal from the EU, comprising the Withdrawal Agreement and Framework for the Future Relationship. That agreement will be subject to confirmation by the Member States, the European Parliament and the UK Parliament in order that it take effect by 29 March 2019, when, in accordance with the terms of Article 50 of the Treaty on the European Union, the UK is set to leave the EU.

Whilst the finer detail of the future relationship will not yet be clear, this is likely to be one of the first opportunities to engage in a high level discussion on all aspects of the future UK-EU arrangements, with some degree of certainty as to their architecture.
